## APPLICATION FOR SENIOR/PERSON WITH DISABILITY DISCOUNT CARD

(For use on StaRT services by Seniors and Persons with Disabilities)

### HOW TO BECOME ELIGIBLE FOR A StaRT SENIOR/PERSON WITH DISABILITY DISCOUNT CARD

In order to be eligible for a StaRT Senior/Person with Disability Discount Card, you must be sixty-five (65) years of age or over, or have a disability. Please complete this application form and return or mail it to Stanislaus Regional Transit, Stanislaus County Public Works Department, Transit Division, 1010 10<sup>th</sup> Street, Suite 3500, Modesto CA 95354. If you are eligible, a StaRT Senior/Person with Disability Discount Card will be mailed to you within 21 days.

### POLICIES

If you lose your discount card, you will need to reapply for a replacement card by filling out another application form. The discount card may be replaced once a year. The discount cardholder may be required to show a photo ID along with the discount card in order to get the discount.

### APPLICATION INSTRUCTIONS

1. If applying for the discount card on basis of age, complete steps 1 and 2.
2. If applying for the discount card on basis of disability, complete steps 1 through 3.
